Notice is hereby given that that Air Georgian Limited ("**Air Georgian**" or the "**Company**") filed a Notice of Intention to Make a Proposal ("**NOI**") on January 31, 2020, pursuant to section 50.4(1) of the *Bankruptcy and Insolvency Act* (the "**BIA**"). KPMG Inc. was named as trustee under the Company's NOI (the "**Proposal Trustee**").

A copy of the NOI and a list of creditors with claims amounting to \$250 or more as known or shown by the books and records of the Company are attached hereto. Please note that the enclosed creditor lists are preliminary and subject to change.

Air Georgian is not bankrupt, but has availed itself of a procedure whereby an insolvent person, with creditor and Court approval, may restructure its financial affairs. As a result of the Company's NOI filing, Air Georgian has obtained the benefit of a stay of proceedings under section 69.1(1) of the BIA, and most creditor claims are in effect frozen by law. These claims may be subject to a Proposal should one be put forward to creditors. Please note that during this process, Air Georgian is continuing its business operations under protection from this legislation. Air Georgian has to file a Proposal with the Proposal Trustee by March 1, 2020, subject to any extension(s) that may be granted by the Court.


The Company was unable to retain a key customer contract, which expired on January 31, 2020. The purpose of the Company's NOI proceedings is to provide a stable environment within which the Company can restructure its affairs and continue to pursue securing a new business relationship.

Our role as Trustee in this matter is to monitor the proceedings, liaise with creditors, and to assist with the development of a proposal to creditors (a "**Proposal**"). We also monitor the receipts and disbursements of Air Georgian during this process.
