- 1. KPMG Inc. (the "Trustee"), in its capacity as Trustee in Bankruptcy of International Fitness Holdings Inc., International Fitness Holdings LP, and World Health North LP (collectively the "IFH Group" or the "Company") is seeking an Order (the "Discharge Order") substantially in the form attached hereto as Schedule "B":
 - a. abridging the time for service of this Application, if necessary, and declaring that this Application is properly returnable today, and that further service of this Application other than to those listed on the Service List established in these proceedings is hereby dispensed with;
 - b. approving the Trustee's Final Statement of Receipts and Disbursements as set out in the Fifth Report of the Trustee, dated April 24, 2023 (the "Fifth Report");
 - c. approving the Trustee's accounts and the accounts of its independent counsel Osler,
 Hoskin & Harcourt LLP, inclusive of accrual for the fees and disbursements of the
 Trustee and those of its legal counsel in connection with the completion of these
 proceedings, including costs of this Application, all as set out in the Fifth Report;
 - d. approving the actions, conduct and activities of the Trustee as described in the Fifth Report and all other reports filed by the Trustee (and previously filed by the Proposal Trustee) in these proceedings;

Grounds for making this application:

- 2. On April 23, 2021 the IFH Group filed a Notice of Intention to Make a Proposal pursuant to Section 50.4(1) of the *Bankruptcy and Insolvency Act*, RSC 1985, c B-3, as amended (the "**BIA**"), and the Trustee was appointed Proposal Trustee.
- 3. On May 27, 2021 this Honourable Court issued an order approving that certain asset sale transaction (the "**Transaction**"), which Transaction subsequently closed.
- 4. With the Transaction having closed, the IFH Group elected not to file a Proposal. Accordingly, upon the expiration of the stay on July 7, 2021 the IFH Group was deemed to have made an assignment into bankruptcy and the Trustee became Trustee in Bankruptcy of the IFH Group.
- 5. With the exception of the completion of some minor administrative tasks, the IFH Group estates have been fully administered, and it is appropriate that the Trustee be discharged as Trustee of the IFH Group upon filing of the Trustee's Certificate confirming the completion of these administrative tasks.
- 6. Such further and other grounds as counsel may recommend and this Honourable Court may permit.
