Stricter immigration controls for seafarers entering Brazil now in force

The Brazilian immigration authority previously accepted a "seaman's book" as a valid seafarer's identity document and a travel document for temporary visa exemption. This book is usually issued under ILO Convention 108. From 1 May 2023, all seafarers arriving in Brazil by plane or vessel must have an ILO C185 SID. Seafarers who do not have an ILO C185 SID, either because their country of citizenship has not ratified the convention or they have not renewed their existing SID, can enter the country with a passport.

Canada increases median hourly wages for employers hiring temporary foreign workers

Employment and Social Development Canada (ESDC), the federal ministry responsible for the labor market has updated the list of median hourly earnings utilized by firms when recruiting foreign nationals under the Temporary Foreign Worker Programme (TFWP). The revised list will go into effect on 31 May 2023.

Canada to start accepting PTE Academic test for Student Direct Stream applications

Canada will begin accepting the PTE Academic on 10 August 2023 for all SDS (Student Direct Stream) applicants. This clearance comes in response to the Department of Immigration, Refugees and Citizenship Canada's (IRCC) earlier this year validation of PTE Core as evidence of English language competency for Canadian citizenship or permanent residency.

Minister of Immigration, Refugees and Citizenship announced new measures to strengthen family reunification such as a new open work permit for spousal and family class applicants, open work permit extensions for permit holders whose permits expire between 1 August and the end of 2023, quicker temporary resident visa (TRV) processing times for spouse applicants etc.

United States change visa reciprocity standards for Libyans

U.S. Embassy in Libya announced on 24 May 2023 a change in the visa reciprocity standards for certain Libyan and U.S. visas. The visa fees have been standardized as part of this reciprocity update, and there are no longer any fees for Libyan nationals. According to the announcement, students from both nations who are eligible for a student visa will now be given multiple-entry visas that are valid for one year instead of the single-entry visa that was previously given out.

The Immigration Department of Hong Kong announced on 24 May 2023 that the visa applicants will be required to declare any previous criminal records from 19 June 2023 onwards, as part of the government's new and expanded measures about assessing entry applications.

India and Australia on 24 May 2023, signed a migration partnership agreement to make it simpler for professionals, academics, and students to reside, work, and study in each other's nations. This task force will report to the ministerial dialogue on the potential for the two nations in relation to green hydrogen.
