## **United States**

USCIS will conduct second random selection from previously submitted FY 2024 H-1B cap registrations

USCIS conducted a random selection process for the fiscal year 2024 H-1B cap, which included beneficiaries eligible for the advanced degree exemption. Individuals with selected registrations will receive a selection notice through their myUSCIS accounts, providing information on when and where to file their H-1B petitions.

## Indonesia announces 10-year visa policy for foreigners

The Immigration Agency of Indonesia has announced that starting from July 2023, they will be implementing the "golden visa" policy, which will allow foreign companies and citizens who invest in the country to obtain special visa privileges.

#### Malaysia

Malaysia offers longer visa-free time to Hong Kong passport-holders

The Government of Malaysia announced that Hong Kong passport-holders can stay in Malaysia for 90 days unlike the previous 30 without a visa. The decision to extend the stay period for Hong Kong passport-holders in Malaysia to 90 days without a visa can be seen as a reciprocal gesture, as Malaysians currently have the privilege of 90-day visa-free travel to Hong Kong.

The Civil Aviation Authority (CAA) of Oman issued a circular stating that specific groups of Omanis are now exempt from the requirement of applying for entry visas when traveling to the Republic of Korea.

# Saudi Arabia

Saudi Arabia expanding e-visa system to 12 countries including Turkey, Lebanon, and Pakistan

The Government of Saudi Arabia announced that the expansion of its e-visa system to include 12 additional countries, bringing the total number of countries eligible for e-visas to 19. With this new system, travelers visiting Saudi Arabia will no longer need to have a visa sticker placed on their passports.

#### **France**

#### France announces plans to welcome 30,000 Indian students by 2030

The Government of France announced that it has set a goal of attracting 30,000 Indian students by the year 2030. This initiative aims to strengthen the bond between the two countries and promote educational opportunities for Indian students in France. The French authorities have proposed a plan where 15-30 public universities will be encouraged to invest in new programs and courses. These initiatives are expected to become financially self-sustainable within two to three years.

## **Portugal**

Foreigners in Portugal whose residence permits expire by 30 September 2023 can renew them automatically

The Government of Portugal have made an announcement stating that all foreigners whose residence permits are set to expire by September 30th will now be able to renew them automatically. The Foreigners and Borders Service has clarified that approximately 84,000 individuals from other countries have residence permits expiring by the end of September.
