Canada

Canada opens new temporary resident pathway for Palestinian extended family in Gaza

Canada has announced the introduction of a temporary residence program for extended family members of Canadian citizens and residents living in Gaza. This program will offer benefits such as health coverage and the opportunity to apply for a work permit or a study permit free of charge. A total of thousand temporary visas will be issued to relatives of Canadians residing in Gaza.

New National Immigration Policy issued

The Chilean government published a Decree in the Official Journal, which establishes the National Immigration Policy, giving it immediate application across the country. It contains the government's strategy with respect to dealing with recent migratory developments in the Latin-American region.

United States

Cap Reached for Additional Returning Worker H-2B Visas for the First Half of FY 2024

The US Citizenship and Immigration Services has reported that it has received enough petitions to reach the limit for the additional 20,716 H-2B visas available for returning workers for the first half of fiscal year 2024. These visas are subject to the H-2B supplemental cap temporary final rule with start dates on or before 31 March 2024.

The United States Citizenship and Immigration Services (USCIS) to launch organizational accounts, enabling online collaboration and submission of H-1B registrations

The USCIS announced a series of customer experience enhancements for the H-1B cap season. These improvements are aimed at enhancing efficiency and facilitating collaboration for organizations and their legal representatives. The changes include the introduction of organizational accounts for non-cap filings and the upcoming H-1B cap season for fiscal year FY25.

Australia

Australia has launched the Pacific engagement visa

The Australian government has introduced a new visa subclass, known as Subclass 192 – Pacific Engagement visa, in 2024. This visa program offers up to 3,000 permanent places annually for citizens of participating Pacific Island countries and Timor-Leste, as well as their immediate family members. This initiative is in addition to Australia's regular permanent migration program.

China lifts and relaxes visa-on-arrival requirements for some categories

The Chinese government has implemented new policies to streamline entry procedures for individuals traveling for business, education, or tourism purposes who hold visa-on-arrival permits. These measures, which took effect in January 2024, enable certain categories of travelers to apply for re-entry visas or port visas upon arrival in the country.

Switzerland and Beijing have reached an agreement where Swiss citizens will be granted visafree entry into China. In return, Switzerland has committed to offering increased visa facilitation for Chinese citizens and Chinese enterprises investing in Switzerland.

Kosovo and Saudi Arabia have reached an agreement for visa exemption for holders of diplomatic and official passports.

Saudi Arabia has launched new residency programs aimed at attracting skilled professionals and investment. The five new premium programs cater specifically to professionals in healthcare, sports, and real estate.

Thai visa-free policy for Chinese visitors to be made permanent in March

Chinese nationals will be granted visa-free entry on a permanent basis beginning 1 March 2024, Chinese visitors have been allowed visa-free entry since September last year, but the privilege was due to expire in February 2024.

The United Arab Emirates has signed an agreement to remove entry visas for Kosovo passport holders.

Iceland

Iceland reinstates pre-pandemic tourist tax

The lcelandic government has reintroduced a tourist tax for hotel and alternative accommodation rooms, a fee that applied to visitors before the COVID-19 pandemic. As of January 2024, travelers to lceland are again obliged to pay taxes for their accommodation in the island country.

Portugal's updated golden visa program sets stage for Investment Fund Growth

Portugal's Golden Visa Program has undergone changes, and it no longer provides residency through property investment. This has led international investors to explore alternative options, such as investment funds, to obtain residency. The changes were introduced as part of the country's "More Housing" bill.

South Africa

South Africa announced automatic extension of exemption permits for nationals of Zimbabwe and Lesotho

Zimbabwean and Lesotho nationals who hold exemption permits have been granted an automatic two-year extension. Exemption permits that expired in December 2023, will now be valid until 29 November 2025.
