SEC Fall 2023 Regulatory Agenda

KPMG Insights:

- Notable Regulatory Rulemaking Still Coming: Upcoming final rulemakings include climate, cybersecurity, conflicts of interest, and market structure.
- **Expansive Rulemaking Agenda:** Expansive rulemaking agenda means that key regulatory actions (though perhaps delayed) are still very much on the regulatory horizon.
- **Date Flexibility:** Rulemaking action dates (e.g., April 2024) are not set release dates, such that rulemaking actions may occur prior to/following the projected action date.

The Securities and Exchange Commission (SEC) releases its Fall 2023 Regulatory Agenda. Notable planned final and proposed rulemakings continue to be recognized in the Agenda stages of rulemaking (some

now with an extended expected release date); select rulemakings are included below. It should be noted that rulemaking actions may occur prior to or following the date noted in the Agenda.
