Withholding

Determining when (and how much) to withhold against payments to U.S. and non-U.S. payees can be a difficult process fraught with nuance. Empowered by the combination of complete client data and our

Working closely with our clients, we review invoices and other sources of payment data, establish the proper tax treatment for each payment, and determine applicable withholding rates, if any. Reporting

Reporting brings our managed services model full circle. Typically, we begin reporting services by claiming relevant and available automatic extensions—including Forms 7004 and 8809—for our clients to better position them to meet the administrative burdens of reporting. We work with our clients to determine which payments and payees need to be reported and document the rationale for the ones that are not reportable. Next, we prepare all the necessary filings for review. Common filings we

cover include Forms 1042-S and 1042, Forms (series) 1099 and 945, Form 8966, and FATCA and CRS XMLs. Special attention is paid to identifying correct status and income codes, increasing accuracy, and reducing risk on audit. Finally, if permitted, we facilitate e-filing (where available) and paper filing (where required) to applicable tax authorities.
