#### **Purchase Price Allocations**

AMAP has tools to help assess the purchase price allocation of acquired properties to tangible and identifiable intangible assets and liabilities. This risk-based approach to valuation helps us more quickly identify and focus on the areas of higher risk, which reduces the overall number of properties tested and helps specifically target certain assets acquired and liabilities assumed.





## Valuation testing for real estate investments

AMAP has customizable analytics to help assess credit risk, valuation and other factors unique to your portfolio, reducing the number of loans subjected to more detailed testing.




#### Risk-based approach to Lease income and Property operating expenses
