


# Enhancing the Planning, Programming, Budgeting, and Execution (PPBE) experience



The Department of Defense's (DoD) Planning, Programming, Budgeting, and Execution (PPBE) process is its main framework for resource allocation and strategic planning. However, the PPBE Reform Commission highlighted significant criticisms of the current PPBE process and calls for change.

In his Message to the Force, the Secretary of Defense emphasized the need for DoD to match threats through capabilities, reforming financial management to proactively and efficiently address mission requirements.

Recognizing the need for transformation, KPMG collaborated with MeriTalk to survey 150 federal financial systems managers and decision-makers across finance and information technology departments to understand their specific challenges.


