### Healthcare regulatory news

USDA [announced](#) a new spillover of a second H5N1 avian flu strain into dairy cattle, though the agency stated the detection does not change its [containment](#) strategy. H5N1 bird flu has been spreading rapidly in wild birds and [transmitted](#) to dairy cattle beginning in March 2024... [66 Americans](#), most of whom worked closely with livestock, were infected with H5N1 in 2024.

A new [infusion treatment](#) for advanced Parkinson's disease received FDA approval. The prescription medicine, ONAPGO, is a wearable device that treats motor fluctuations in adults with the condition.

The NIH will impose a [15% cap](#) on “indirect costs”, which include overhead and administrative expenses, in research grants with the goal of directing more money toward direct research costs; the announcement has [raised concerns](#) about the impact of the funding change on scientific research.



## Healthcare law and policy news

The Senate Finance Committee voted to [advance](#) Robert F. Kennedy Jr.’s nomination as HHS Secretary, and a full vote on his confirmation may occur as early as this week.

Maryland Governor Wes Moore [announced](#) the appointment of Dr. Meena Seshamani as the state’s Department of Health Secretary. Dr. Seshamani formerly served as Director of Medicare and Deputy Administrator at CMS under the Biden administration.

A nonprofit healthcare advocacy group filed a [lawsuit](#) against the Trump administration for removing webpages and datasets from the websites of the CDC, FDA, and HHS. Plaintiffs [argue](#) that the action violates the Administrative Procedures Act (APA) and the Paperwork Reduction Act (PRA), and request the restoration of all webpages and datasets.

According to a new [poll](#) from Gallup and Emory University’s Rollins School of Public Health, healthcare access and affordability remain key concerns for Americans. [Out of pocket healthcare expenditures](#) continue to rise annually for most Americans and [23% of Americans](#) are considered underinsured.

The California Department of Housing and Community Development [sent a report](#) to the state legislature urging lawmakers to set cooling standards for residential dwellings at 82 degrees, citing the negative effects from long-term heat exposure. Recently, [local](#), [state](#), and [federal](#) lawmakers have introduced policies to reduce exposure to extreme temperatures.
