## United States: IRS Issued Update on IDES Manual Email Notifications

On 04 September 2024, the Internal Revenue Service (IRS) announced that it is delaying manual email notifications for FATCA International Data Exchange Service (IDES) transmissions due to system issues. The IRS initially announced it was manually confirming transmissions in a 30 July 2024, communication, [here](#). Due to the system error, manual IDES confirmations will be sent during the second week of September. Users are reminded to keep their settings properly configured to receive the IDES alerts.

The IRS further reminds users that are encountering “Failed Decompression – Decompression Failed” or “Failed Signature Check – Invalid Digital Signature” errors on their IDES transmissions to confirm that their certificate is uploaded and current on the IDES enrollment website. In addition, users must ensure that they are following the IRS best practices for data preparation and upload.
