Purpose	Notification of the list of participating jurisdictions for the 2025 filings.

List of Participating Jurisdiction under the Common Reporting Standard

The public is asked to take note of those jurisdictions that are Participating Jurisdictions for the purposes of the Common Reporting Standard (“CRS”) for the 2025 filings (i.e. for the reporting year 2024).

For the purposes of CRS, (Automatic Exchange of Information) Regulations, 2017, a participating jurisdiction is defined as a jurisdiction that has implemented the CRS and with which an agreement is in place to exchange CRS information with Barbados.
