## Finland: Issued Newsletter on FATCA and CRS Submission Deadlines

On 17 January 2025, the Tax Administration of Finland published a newsletter reminding Financial Institutions (FIs) that FATCA and CRS annual information returns for 2024 should be submitted to the Tax Administration by 31 January 2025. The annual information returns must include up-to-date contact details in case the Tax Administration has any queries. The reporting FI should review any comments provided and correct their reports accordingly.

The newsletter also highlights the following points:

- FIs must accurately provide information for the account holder's identity, such as name, Tax Identification Number (TIN) and date of birth. This allows the receiving countries to automatically identify the reported account holders. See detailed instructions, [here](#).
- The Tax Administration has prepared a FATCA Checklist, [here](#), and a CRS Checklist, [here](#), which each contain a series of useful tips to support FIs in preparing the annual information returns.
- A US TIN is mandatory for the FATCA annual information return. In cases where the FI is missing the account holder's US TIN, the appropriate code for each instance should be entered in the TIN element by adhering to the FATCA technical guidance, [here](#).

In addition, the deadlines for submission of the annual information returns can only be extended until 31 March 2025. Any request for extension must be clearly justified and must be made by 31 January 2025 by emailing [fatca@vero.fi](mailto:fatca@vero.fi).
