Finland: Updated FATCA and CRS FAQs

On 28 February 2025, the Tax Administration of Finland updated Section 1 of its FATCA and CRS Frequently Asked Questions (FAQs), dealing with fulfilling due diligence obligations. A question regarding whether a self-issued certificate is needed from an existing customer when opening a new account was updated. The answer was revised to clarify that a self-issued certificate from the customer is not considered a pre-requisite for account opening, where no additional customer information is required by other legislation, for technical account openings involving time deposits that renew automatically without customer involvement.
